- Subscriptions are due 1 April annually.
- If joining the Society between 1 April and 30 September the full subscription is payable, either by our preferred method of Standing Order or by cheque.
- If joining between 1 October and 31 March we offer a 50% reduction in the first year's subscription, payable by cheque. Thereafter on the following 1 April you have the option to pay the annual subscription either by Standing Order or by cheque.
